Conditions:

- a) Interested/Eligible Bidders can purchase the tender documents online from website. eproce.punjab.gov.in
- b) Bidders have to pay the Processing fee only through internet banking, for queries at e-banking.
- c) Earnest Money and tender form fee shall be paid on -line through Net Banking.
- d) Bidders / Contractors/tender document into Electronic Tender on the website mentioned above fill them and submit the complete tender document into Electronic Tender on the website itself. Bidders/Contractors shall attach scanned copies of all the papers, i.e. Earnest Money processing fee, Tender Cost fee and certificates as required in terms and conditions.
- e) Corrigendum/Addendum/Correction, if any will be published on the website only.
- f) NIT, terms and conditions are being uploaded at the etender.punjabgovt.in only for viewing. Agencies should note that online tenders will be only submitted at the aforesaid website. eproc.punjab.gov.in (Being uploaded shortly) as per the details/instructions uploaded therein.
- g) All the terms and conditions of S.B.D.approved by PWD(B&R) Punjab will be applicable.
- h) As per notification dated 02.08.2018 of Department of Local govt.Punjab. All the Tenders uploaded on the E-Tendering website shall be on two bid basis i.e. Technical bid and Financial bid. The following scanned document should be also uploaded along with tender documents:-
 - a) PAN number of the Contractor/L&C Society /Firm
 - b) GST number
 - c) EPF number ESI number where applicable
 - d) Valid Enlistment Certificate
 - e) Self-declaration that the Contractor/L&C Society /Firm has not been black listed till the publication of Tender notice.
 - f) In case of L&C Society, list of Members of the Society, their ID proofs & capacity certificate issued by Registrar Co-op Societies
 - g) Intending Bidders shall submit an undertaking that the sum total of works being bid does not exceed their bid capacity by the deducting value of all works in hand(in all departments) at that point of tiem. In the event that information provided by the bidder is found to be false or misrepresentative, the Tender would be liable for cancellation including forfeiture of the Earnest Money deposited by the Bidder.
 - h) If the Financial bid quotes more than 25% saving from the estimated cost, the Engineer may ask the bidder to produce detailed analysis for any or all the items to check the viability of rates w.r.t to construction.
 - i) methodology & workability. After evaluation of price analysis, the ULB may askl the Bidder to give an additional Bank Guarantee @5% of the estimated amount (to remain valid till the time period of the refund of security) so as to protect against financial loss in event of subsequent default by the Bidder for not completing the works etc.
 - j) All the above said documents should be uploaded with tender, failing which the tender will not be entertained.
 - k) If at the time of submission of e-tender, any error occurs due to technical reason of website, improvement trust, Pathankot.org will not responsible.

- m) If holiday is declared on the date of tender then tenders will be received/opened on next working day.
- n) Any A & C slip issued on CSR till the date of receiving of tender will be applicable for measurements and payments.
- o) Before permitting the use of interlocking tiles concrete pavers, necessary tests should be performed to ensure that the pavers are confirming to IS:15658. The pavers should be laid as per IRC:63 guidelines, especially the grading of sand to be used for bedding and filing of joints between the pavers.
- p) Only freshly procured first class bricks shall be used for laying brick on edge. No old brick retrieved from dismantling of existing payment shall be re-used for laying brick on edge.
- q) Except minimum Wages the Labour will be paid Statutory, EPF & ESI or other Benefits.
- r) The payment will be paid to the Labour by the Contractor through Cheque. As per rules all the benefits given to the Labour benefits such as EPF & ESI.
- s) The payment will be paid to the contractor after taking the receipts in the record.
- t) Labour register should be maintain by the contractor. The presence of the labour will be chequed by the EO & Checking Should be Maintained in the record.
- u) The payment will be made as per the presence of the labour. if there is any discrepancy in the labour register, Necessary action will be taken against the contractor.
- v) The contractor /Society Should be registered in labour department, ESI, & EPF Department
- w) All the garbage/ Kura-Karkat Should be in the Container at the secondary.
- x) The Kura-Karkat Trolley should be covered with tarpal.
- y) The contractor should maintain the rules of Municipal Solid waste rules 2000.
- z) As per common action plan, the container Emptid in Twice as day.
- z-1) The Work order for the work at Sr. No. 2 will be given after the approval of the resolution No. 64 of dt. 30-6-2022 after the approval of the Government.
